#### 1. CALL TO ORDER:

The Chairman, Frederick T. Stant, III, called the meeting to order at 9:30 a.m. and welcomed everyone.

#### 2. APPROVAL OF MINUTES – MAY 10, 2022 MEETING, as distributed:

Motion made by Mr. Duncan, seconded by Mr. Ferguson, to approve the minutes of the May 10, 2022 Commission meeting, as distributed. The motion was approved unanimously.

#### 3. PUBLIC COMMENT:

There were no public comments to be heard, nor any comments submitted in writing prior to the meeting.

Mr. Stant introduced the two new Commissioners, Mark Bundy and Phillip Custis. Commission members and staff then introduced themselves.

Mr. Holland congratulated Mr. Colonna and Mr. Stant on their recent reappointments and thanked them for their continued service.

#### 5. OPERATIONS SMILE PRESENTATION:

Ms. Clifford was present to provide the Commission an overview of Operation Smile. Ms. Clifford requested permission that in honor of Operation Smile's 40th Anniversary, a Cycle for Smiles commence across the Chesapeake Bay Bridge-Tunnel and continue to the Global Headquarters, a select team compiled of the Virginia Beach founders and student leaders of Operation Smile will cycle 40 miles to culminate 40 rides in 40 regions of the World.

# RESOLUTION COMMENDING OPERATION SMILE ON THE OCCASION OF ITS 40th ANNIVERSARY

WHEREAS, Operation Smile is a private, not-for-profit volunteer medical services organization providing reconstructive surgery and related health care to indigent children and young adults in developing countries and the United States; and,

**WHEREAS**, in 1982, Dr. William P. Magee Jr., a plastic surgeon, and his wife, Kathleen S. Magee, a nurse and clinical social worker, traveled to the Philippines with a group of medical volunteers to repair children's cleft lips and cleft palates; and,

**WHEREAS,** Operation Smile headquartered in Norfolk, Virginia, was founded in 1982 by Dr. William Magee Jr. and his wife Kathleen S. Magee to address this need; and,

WHEREAS, since 1982, Operation Smile's volunteers have provided free reconstructive surgery to more than 326,000 people receive life-changing surgical and dental care; and,

**WHEREAS,** Operation Smile provides education and training to thousands of healthcare professionals globally, and is implementing a plan for a Global Standard of Care to ensure that every child treated will receive the same high standard of care every time; and,

WHEREAS, Operation Smile provides a network of resources to assist families in the United States with children born with facial deformities; and,

**WHEREAS**, more than 450 Operation Smile Student Associations in the United States and around the world build awareness, raise funds, and educate students about values of commitment, leadership, and volunteerism; and,

WHEREAS, in 2022, in commemoration of its 40th anniversary, Operation Smile has announced a Cycle for Smiles a Global Celebration, which consists of teams of 40 cyclist

to cycle 40 m/km in 40 regions with the goal of launching a 10-year impact plan to provide care to 1 million patients; and,

WHEREAS, on Sunday, October 30, 2022, in honor of Operation Smile's 40th Anniversary, a Cycle for Smiles will commence across the Chesapeake Bay Bridge-Tunnel and continue to Global Headquarters, a select team complied of the Virginia Beach founders and student leaders of Operation Smile will cycle 40 miles to culminate 40 rides in 40 regions of the World;

**NOW, THEREFORE, BE IT RESOLVED** That the Chesapeake Bay Bridge and Tunnel Commission congratulates Operations Smile on the occasion of 40 years of incorporation and wishes them every success with their 40th Year Global Celebration, which will be held on the Chesapeake Bay Bridge-Tunnel facility on October 30, 2022.

Bridgette Clifford and Delegate Tata departed the meeting at this time.

# 6. TRAFFIC & REVENUE REPORT – MAY & JUNE, HOLIDAY WEEKEND TRAFFIC:

Mr. Holland reported that traffic for May 2022 totaled 372,657 vehicles, which was a decrease of 15991 vehicles or -4.1% under May 2021. E-ZPass utilization totaled 73.6%. Revenue for May 2022 totaled \$6,013,011 which was a decrease of \$233,033 or -3.7% under May 2021. Gas prices were \$4.55 in May 2022, versus \$3.01 in May 2021. There were 32 hours of wind restrictions in May 2022, versus 13 hours in May 2021. There were 45 hours of tunnel lane closures in May 2022, versus 82 hours in May 2021.

Traffic for June 2022 totaled 397,747 vehicles, which was a decrease of 24,950 vehicles or -5.9% under June 2021. E-ZPass utilization totaled 73.1%. Revenue for June 2022 totaled \$6,716,637, which was a decrease of \$334,022 or -4.7% under June 2021. Gas prices were \$4.69 in June 2022, versus \$2.97 in June 2021. There were 7 hours of wind restrictions in June 2022, versus 4 hours in June 2021. There were 97 hours of tunnel lane closures in June 2022, versus 107 hours in June 2021.

For the calendar year-to-date through June 2022, vehicles were up 1.7% and revenue was up 2.2%. For the fiscal year-to-date through June 2022, vehicles were up 14.1% and revenue was up 13.8%.

#### 7. WIND ADVISORY & RESTRICTION POLICY AMENDMENT:

Mr. Holland reported each of the changes made to Wind Advisory and Restriction Policy. He stated that purpose for restructuring the current program makes the different wind levels more practical for the District to implement and administer.

Motion made by Mr. Rowland, seconded by Mr. Ferguson and unanimously carried, the Commission approved the amended Wind Advisory and Restriction Policy as recommended, effective July 1, 2022 and a copy is attached to the minutes.

#### 8. PRELIMINARY ACTUAL TO BUDGET ANALYSIS FY 2022:

Mr. Anderson reported that projected actual expenditures for the fiscal year ended June 30, 2022, totaled \$15,688,997; budgeted expenditures totaled \$16,362,200; for a variance of \$673,202 or 4.1% under budget.

#### 9. AWARD OF FUEL CONTRACT:

Mr. Crist reported that the District Fuel Contract was awarded to World Fuel Services, Inc. The District requested a quote on fixed pricing through September 2022 and found that pricing was not favorable. The District will continue to monitor pricing and adjust if opportunities are available.

#### 10. PILE JACKET DEMONSTRATION PROJECT:

Mr. Crist reported that the original Pile Project was approved in March of 2022. The District surveyed the entire industry and nothing fit the facility's needs for long-term durability. District staff is trying to develop a system that can apply across 200 pilings along the facility and be cost effective. The District received a proposal from Crofton, a contractor and a manufacturer of Carboshield. This project would include test installation methods on six piles at the beach. Three of the piles would be tested with an adhesive system and the other three would be tested with mechanical anchors. These methods would eliminate marine challenges and reduce labor cost. District staff request authorization to proceed with this proposal with Crofton for an estimated cost of \$423,829 but not to exceed \$450,000.

Motion made by Mr. Duncan, seconded by Mr. Rowland, and unanimously carried, the Commission authorized District staff to execute the Pile Jacket Demonstration Project and to be performed by Crofton at a not to exceed cost of \$450,000.

*Mr. Bundy abstained from the vote.* 

#### 11. VRSA RENEWAL COMPARISON:

Mr. Anderson updated the Commission regarding the VRSA Insurance renewal for property, liability, worker's compensation, cyber liability, and LODA insurance for the upcoming fiscal year. The total renewal cost was a variance of approximately \$12,821 or an 4.10% increase from the previous year. The total premium for FY 2023 is \$325,557 versus the expired premium of \$312,736 for 2022. The District's annual insurance policy

line item funds are allocated in the annual operating budget that the Commission approves in May of each year.

# 12. UPDATE ON PARALLEL THIMBLE SHOAL TUNNEL (PTST) DESIGN AND CONSTRUCTION:

Mr. Crist reported the following: i.) CTJV continued driving the interlocking pipe pile support of excavation (SOE); ii.) CTJV is driving pipe piles for both the east and west walls. As of April 30, 2022, CTJV had installed approximately 86% of the piles. iii.) CTJV continues installing the concrete slabs in the open approach. iv.) Installation of the conveyor belt structure has begun along the muck pit's eastern side. v.) CTJV continued jet-grouting operations in the open approach area. vi.) CTJV is erecting the Omega trestle on Two Island.

#### 13. PARALLEL THIMBLE SHOAL TUNNEL EXPENDITURES TO DATE:

Mr. Anderson presented the attached report of Project expenditures to date.

#### 14. UPDATE ON THE NORFOLK HARBOR CHANNEL DEEPENING PROJECT:

Mr. Crist provided an update on the Norfolk Harbor Channel deepening project pertaining to the Thimble Shoal Tunnel cover. During this project, the cover that is currently over Thimble Shoal Tunnel will have to be adjusted in order to get to the 55 ft. depth that they are trying to achieve. The current design cover over the tunnel is at 10 ft. and they have to reduce it to 5 ft. In order to do this, the port will dredge a 10 foot pit to the east of the tunnel and utilize a water injection dredging process and blow the sand off of the top of the tunnel. A rock blanket will be installed in order to protect the existing tunnel.

#### **15. ANNOUNCEMENTS:**

- a. Mr. Holland announced that the Commission, employee, and retiree picnic will be held on October 29, 2022, here on the courtyard of the Administration Building.
- b. Mr. Holland reminded the Commissioners to schedule their Vascular screening during July 18 through July 29.

- d. Mr. Holland announced that for the final 6 months of 2022, the standard mileage rate for business travel will be 62.5 cents per mile, up 4 cents from the rate effective at the start of the year.
- e. Mr. Holland announced that the next Regular Commission meeting is scheduled for Tuesday, September 13, 2022.

With no further business coming before the Commission, the meeting was adjourned.

# **Chesapeake Bay Bridge and Tunnel Wind Advisory and Restriction Policy**

Category / Level	Average Wind Speed (mph)	Vehicle Restrictions
Advisory	35	Speed limit reduced to 45mph  No Passing
Level I - Restrictions	40	The following types of vehicles will NOT be allowed to cross the facility:  • Motorcycles • Large pick-up campers (RVs) • Camper trailers • House trailers • Anything being towed • Vehicles with exterior cargo that may become unsecured due to high winds • 6-wheel trucks; such as moving vans, rental trucks, box trucks • Buses • Empty tractor-trailers (less than 15,000 lbs. cargo)  The following types of vehicles WILL be allowed to cross the facility: • Tractors without trailers • Empty flatbed trailers • Empty car carriers • Empty logging trailers • Tractor-trailers (and tankers) must gross 15,000 pounds payload in addition to the weight of the rig Speed limit is reduced to 45mph No Passing
Level II - Restrictions	50	The ONLY types of vehicles allowed to cross are:  cars without exterior cargo; pick-up trucks (to include 2-axle, 6 wheels) without cargo; mini-vans; vans not to include high-profile/conversion vans; SUVs;
Level III – Closed	60+	Closed to all traffic due to weather conditions or safety concerns.
